Mr. Gates, Ms. Riordan,

The Illinois State Board of Elections (SBE) is in receipt of your letter dated 7/28/25, regarding voter list maintenance in Illinois. In response to your request, SBE is attaching a list of officials who are responsible for voter list maintenance activities in Illinois as Exhibit A. Attached as Exhibit B is Illinois' most recent statewide voter registration list in a comma delimited-text file format as requested, along with Exhibit C, which is a file layout identifying each category of voter data provided. This list is being provided pursuant to Section 20507(i) of the National Voter Registration Act, 52 U.S.C. § 20507(i), and as authorized by Section 1A-25(b) of the Illinois Election Code, 10 ILCS 5/1A-25(b), which permits disclosure of the centralized statewide voter list to "a governmental entity for a governmental purpose[.]" SBE ordinarily charges a \$500 fee for providing a statewide voter list pursuant to the National Voter Registration Act, but we are waiving the \$500 fee here.

We ask that you please refrain from disseminating this voter list outside your office without first notifying me in writing, as the list contains data that is not available to the general public. Signature clips are not included in Exhibit B but are available for viewing on a

computer screen during normal business hours at SBE's principal office located at 2329 S. MacArthur Blvd., Springfield, IL 62704. *See* 10 ILCS 5/1A-25(b). More information about the Illinois voter list and the laws governing its dissemination is provided in the attached Exhibit D. As explained in Exhibit D, voter dates of birth, driver's license and state ID numbers, and social security numbers are not included in the Exhibit B voter list.

SBE would greatly appreciate an extension of time until September 10, 2025, to respond to your remaining inquiries, allowing us a fuller opportunity to analyze and answer your requests. Please feel free to reach out with questions.

Missing Voter History Data for Registered Voters in Three Counties

In Illinois, each of the State's 108 local election authorities uses a voter registration vendor to enable them to enter voter data into the Illinois Voter Registration System (IVRS) and perform list maintenance. This year, three Illinois counties – Gallatin, Alexander, and Union County – switched vendors from Platinum Services to different vendors. During this transition, voter history from these counties' registered voters did not successfully transfer from the old vendor and do not currently appear in IVRS. Our understanding is that these counties are working with their new vendors to restore the missing voter history information for voters in these three counties, and we are optimistic this data will be restored in the near future.
